1. A SIDEWALK SHALL BE PROVIDED ALONG BOTH BRIDON CIRCLE & COMMERCE STREET. THE SIDEWALK SHALL BE CONSTRUCTED PRIOR TO THE ISSUANCE OF THE CERTIFICATE OF OCCUPANCY FOR THE AFFECTED LOT. THE SIDEWALK ALONG COMMERCE STREET SHALL BE CONSTRUCTED WITH THE CONSTRUCTION OF BRIDON CIRCLE.
2. TREES SHALL BE PLANTED WITHIN THE COMMON AREAS ADJACENT TO COMMERCE STREET.
3. MAINTENANCE OF THE COMMON AREAS SHALL BE THE RESPONSIBILITY OF THE PROPERTY OWNERS ASSOCIATION.
4. THIS PLAT OF SURVEY MEETS THE OKLAHOMA MINIMUM STANDARDS FOR THE PRACTICE OF LAND SURVEYING AS ADOPTED BY THE OKLAHOMA STATE BOARD OF REGISTRATION FOR PROFESSIONAL ENGINEERS AND LAND SURVEYORS, AND THAT SAID FINAL PLAT COMPLIES WITH THE REQUIREMENTS OF TITLE 11 SECTION 41-108 OF THE OKLAHOMA STATE STATUTES.

6. THE FINAL PLAT BOUNDARY AND LOT CORNER MONUMENTS SHALL BE AS FOLLOWS:
#3 BAR WITH CAP STAMPED "DURHAM CA 5313" UNLESS OTHERWISE NOTED
7. SIGHT-PROOF SCREENING SHALL BE PLACED ALONG THE SOUTH BOUNDARY OF LOTS 3 & 4, BLOCK 1 OF BRIDON BUSINESS PARK AND SHALL BE MAINTAINED BY THE OWNERS OF RECORD.
8. ALL PRIMARY STRUCTURES SHALL HAVE A BRICK FACADE ON ALL SIDES.





