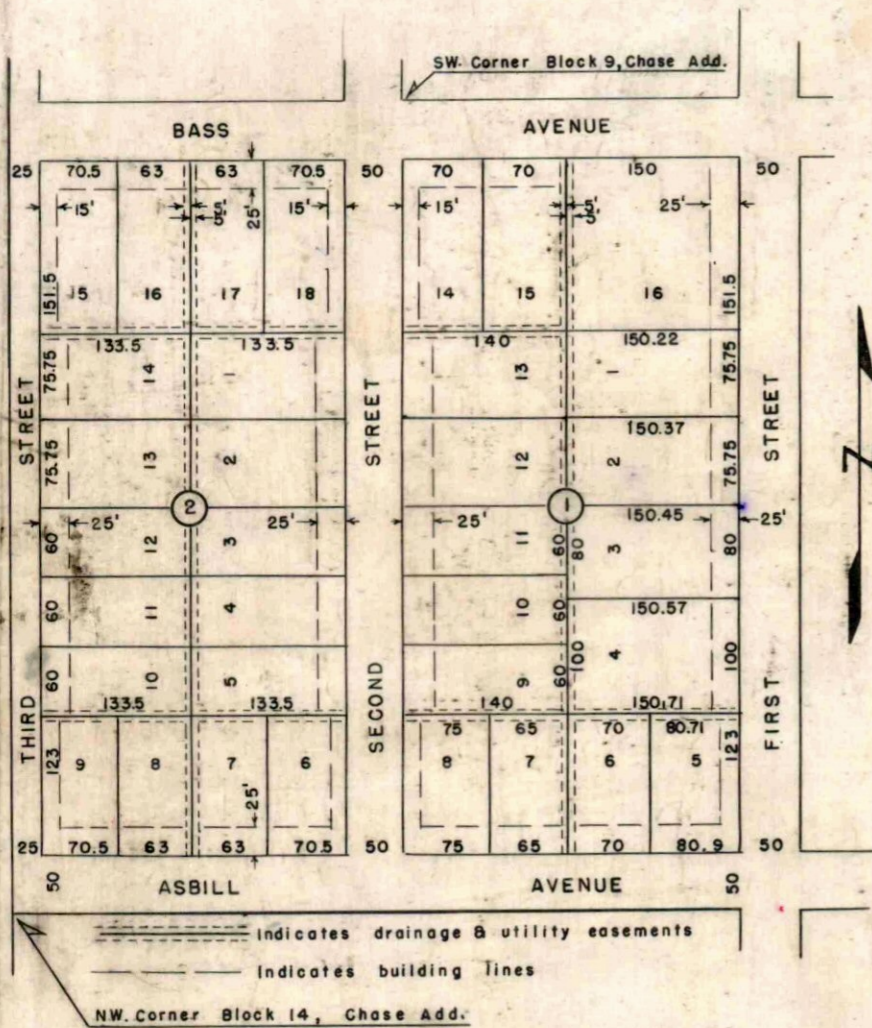


**SUB-DIVISION OF BLOCKS 10 AND 13
