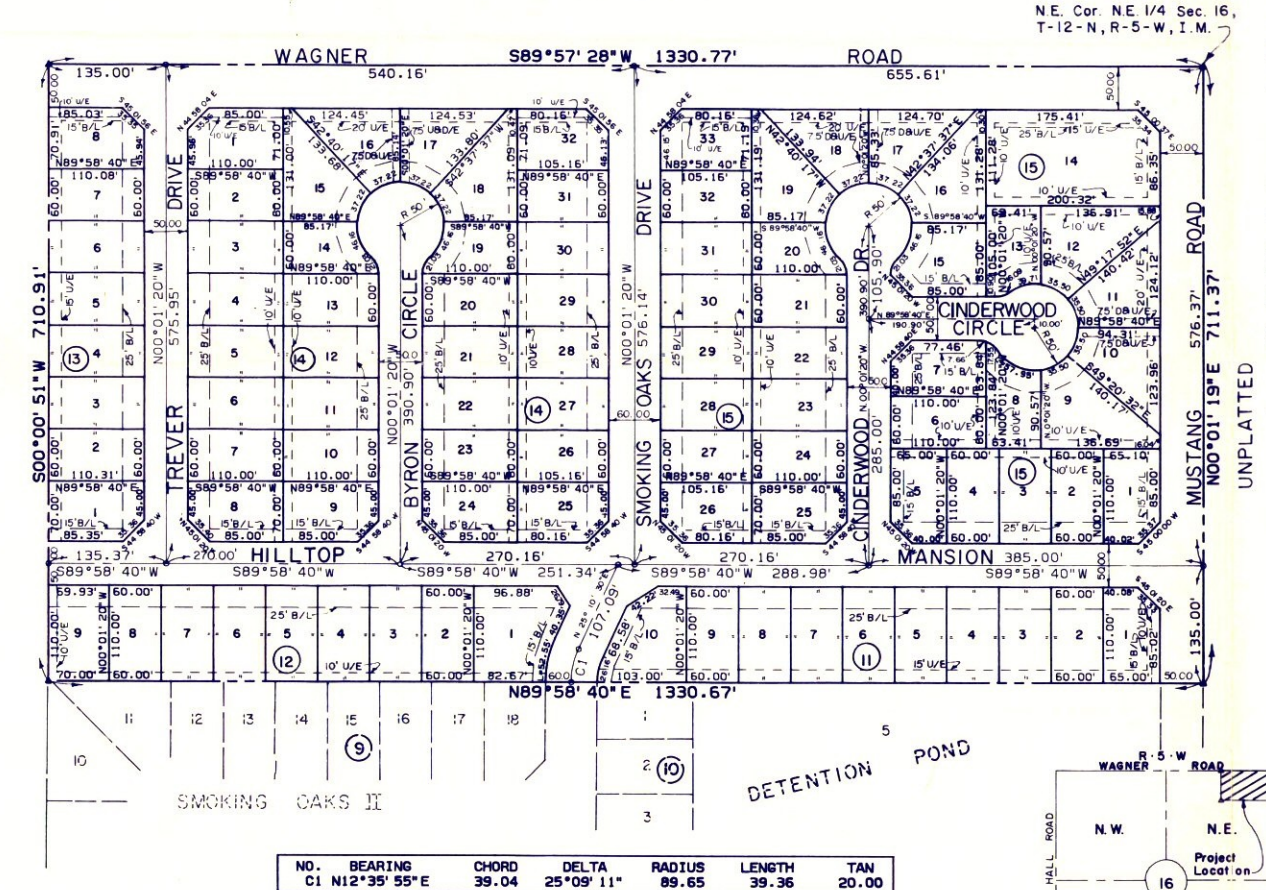

CITY COUNCIL APPROVAL

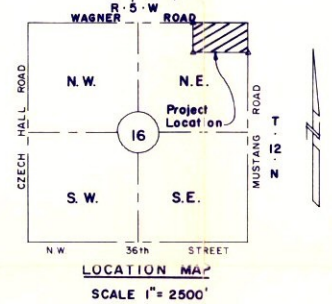
