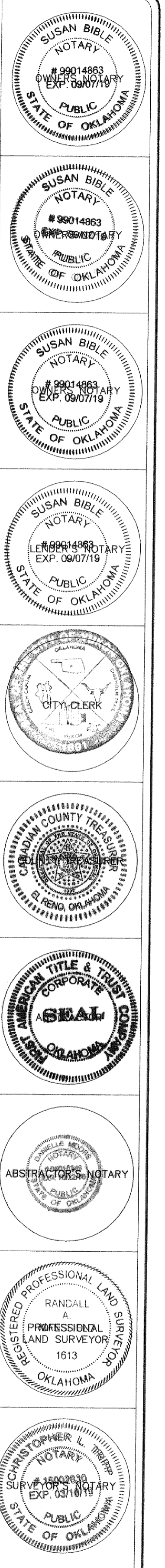

LEGAL DESCRIPTION

A tract of land being a part of Lot One (1), Block One (1), WEST END POINTE ADDITION, PHASE II, SECTION 1, an Addition to the City of Yukon, Canadian County, Oklahoma, according to the recorded plat thereof in Book 9 of Plats, Page 95, and an unplatted part of the Southwest Quarter (SW4) of Section 29, Township 12 North, Range 5 West of the Indian Meridian, being more particularly described as follows:

COMMENCING at the southwest corner of said Southwest Quarter;

THENCE North 89°59'58" East, along the south line of said Southwest Quarter, a distance of 1,099.78 feet;

THENCE North 00°00'02" West a distance of 50.00 feet to a point on the easterly right of way line of West End Pointe Drive and the POINT OF BEGINNING;

THENCE along said easterly right of way line, the following Two (2) courses:

1. North 45°07'38" West a distance of 35.43 feet;

2. North 00°15'13" West, passing at a distance of 1,072.06 feet the southwest corner of said Lot 1, Block 1, and continuing for a total distance of 1,201.25 feet;

THENCE North 90°00'00" East a distance of 171.87 feet;

THENCE North 34°30'28" East a distance of 120.00 feet to a point being the southwest corner of Lot 2, Block 1, WEST END POINTE ADDITION PHASE II SECTION 1;

THENCE along the easterly line of Lot 1 and the southerly line of Lots 2, 3, 4 and part of Lot 5, Block 1, WEST END POINTE ADDITION PHASE II SECTION 1, the following two (2) courses:

1. South 56°12'53" East a distance of 158.84 feet;

2. South 55°28'32" East passing at a distance of 92.38 feet to the most northerly southeast corner of said Lot 1 and continuing along the southerly line of said Lots 3, 4 and part of Lot 5 for a total distance of 561.29 feet to a point on the westerly line of Lot 6, Block 1, of said WEST END POINTE ADDITION, PHASE II, SECTION 1;

THENCE along the northwesterly line of said Lot 6, the following Two (2) courses:

1. South 34°30'28" West a distance of 243.04 feet to a point of curvature;

Southerly along a curve to the left having a radius of 150.00 feet (said curve subtended by a chord which bears South 11°59'42" East a distance of 217.62 feet) for an arc distance of 243.49 feet to a point on the northeasterly line of Lot 8, Block 1, WEST END POINTE ADDITION, PHASE II, SECTION 2, recorded in Book 9 of Plats, Page 151;

THENCE along the northeasterly, northwesterly and easterly lines of said Lot 8, the following Four (4) courses:

1. North 58°29'53" West a distance of 167.57 feet;

2. South 34°42'47" West a distance of 422.55 feet;

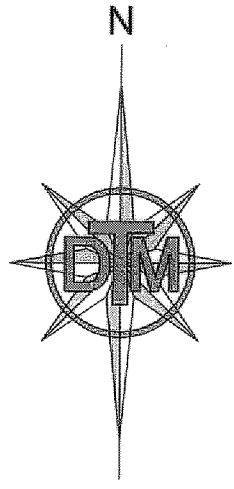
3. South 90°00'00" West a distance of 107.94 feet;

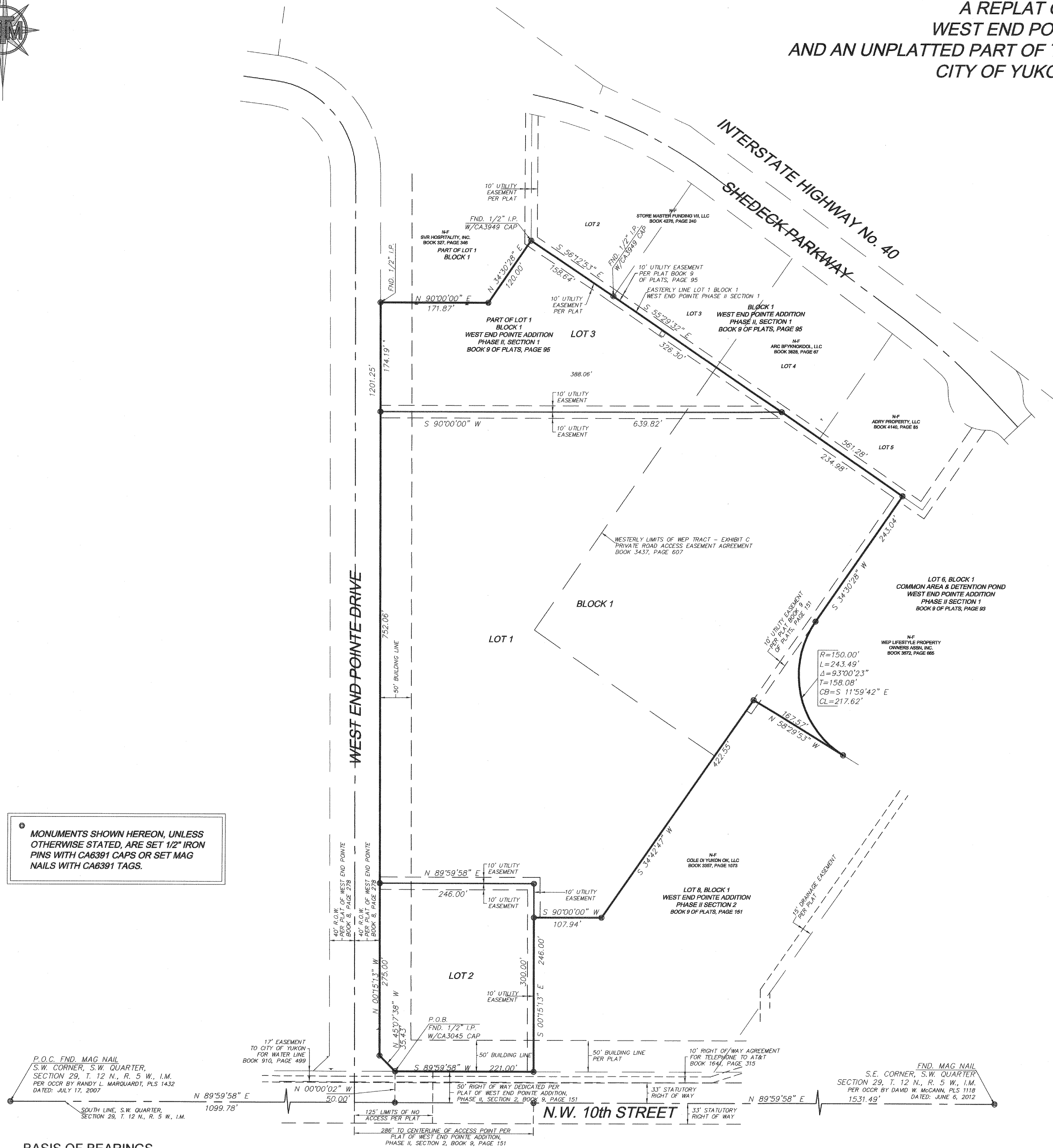
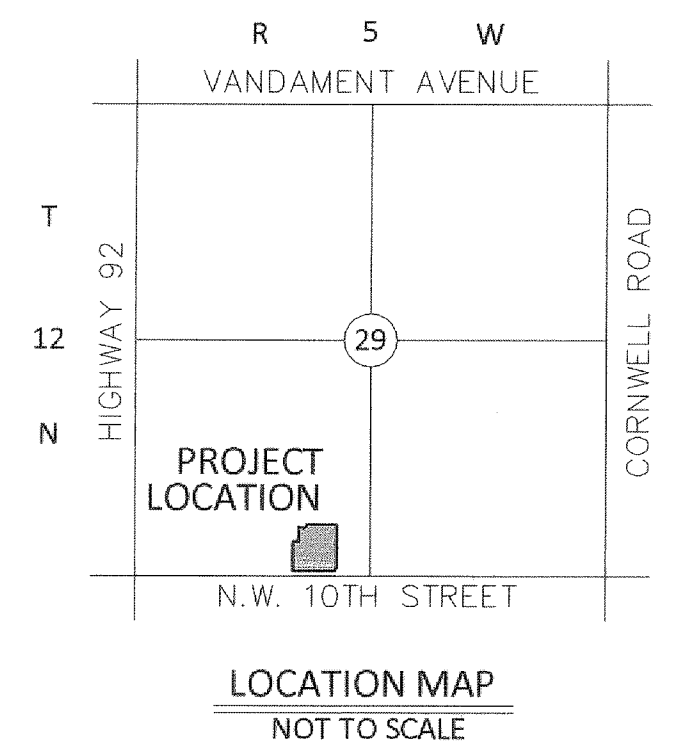

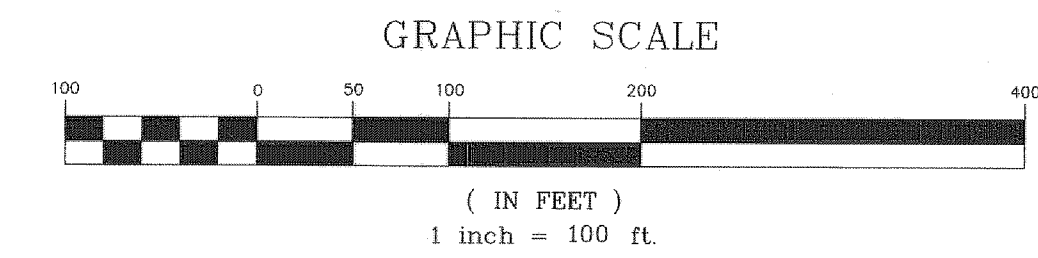
