



Sign Permit Application Packet

No sign may be erected, constructed, structurally altered, moved, extended, enlarged, replaced or removed without the owner or operator first obtaining a sign permit.

The Sign Permit Application must be accompanied by the following:

- ☐ **Completed & Signed Application**
- ☐ A site plan containing the information showing the street address of the property upon which the subject sign is to be located, the proposed location of subject sign on subject property, the distance of the proposed sign from the subject property's boundaries and Right-of-Way and all existing structures or buildings on the subject property.
- ☐ Dimensioned plan showing frontage of building with the **property owner's signature** on each copy indicating the position of the sign with respect to nearby building(s) / structure(s)
- ☐ Picture / drawing of the proposed sign as it will be seen on the building elevation / frontage with dimensions, including proposed colors and material with the **property owner's signature** on each copy
- ☐ An elevation of the proposed sign with dimensions (width and height)
- ☐ Wind load calculations
- ☐ A copy of stress diagrams of plans
- ☐ The owner(s) of the property or his/her agent, **must sign-off on the application**, granting the applicant permission for the placement, maintenance, size and height of the subject sign to be placed on the property.

Following review by the Development Services Director or his/her designee, the sign permit will be approved with conditions or denied. All sign applications will be reviewed within 5-7 working days.
